A RESOLUTION OF THE MIAMI CITY COMMISSION AFFIRMATIVELY OPPOSING THE SECOND WEEKEND OF THE ULTRA MUSIC FESTIVAL IN BAYFRONT PARK, MORE SPECIFICALLY MARCH 22, 2013 THROUGH MARCH 24, 2013, DIVESTING THE BAYFRONT PARK MANAGEMENT TRUST OF THE POWER TO HOLD THE ULTRA MUSIC FESTIVAL ON SAID SECOND WEEKEND OF THE ULTRA MUSIC FESTIVAL; DIRECTING THE CITY CLERK TO TRANSMIT A COPY OF THIS RESOLUTION TO THE BAYFRONT PARK MANAGEMENT TRUST.

WHEREAS, the Ultra Music Festival intends to hold a two (2) weekend event on March 15, 2013 through March 17, 2013 and March 22, 2013 through March 24, 2013; and

WHEREAS, said event will be disruptive to the local business community and area residents due to noise, nuisance behavior by festival goers, and grid locked traffic; and

WHEREAS, one weekend of disruption may be tolerable to residents and the business community, but two (2) consecutive weekends will cause disruptions in work in local offices and create difficulty in accessing residential buildings; and

WHEREAS, per Section 38-104 of the Code of the City of Miami, Florida, as amended ("City Code"), the Bayfront Park Management Trust has "the power to do all things necessary to direct, manage and maintain Bayfront Park..."; and

WHEREAS, Section 38-104 of the City Code conditions that power by providing that Bayfront Park Management Trust's broad powers are, "subject at all times to city commission approval..."; and

WHEREAS, the Miami City Commission affirmatively disapproves of the proposed second weekend of the Ultra Music Festival in Bayfront Park;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

Section 1. The recitals and findings contained in the Preamble to this Resolution are adopted by reference and incorporated as fully set forth in this Section.

Section 2. The Miami City Commission affirmatively disapproves of the proposed second weekend of the Ultra Music Festival's to take place March 22, 2013 through March 24, 2013 and hereby divests the Bayfront Park Management Trust of the power to allow a second weekend of Ultra Music Festival on that date.

Section 3. The City Clerk is hereby directed to transmit a copy of this Resolution to the Bayfront Park Management Trust.

Section 4. This Resolution shall become effective immediately upon its adoption and signature of the Mayor.{1}

{1} If the Mayor does not sign this Resolution, it shall become effective at the end of ten (10) calendar days from the date it was passed and adopted. If the Mayor vetoes this Resolution, it shall become effective immediately upon override of the veto by the City Commission.
